Mineral Resource Estimates Torrington Project – New South Wales

Chase Mining Corporation Limited sets out in the table below its Mineral Resource Estimates for the Torrington Project as at 30 June 2019. The estimates are reported in accordance with the 2012 JORC Code and Guidelines and are consistent with previously reported estimates as announced to the ASX.

The Mineral Resource estimation for Wild Kate and Mt Everard was prepared by H&S Consultants, Brisbane and previously reported to the ASX on 22 March 2018 on behalf TopTung Limited ASX:TTW*.

The Company confirms that it has reviewed the JORC 2012 Mineral Resource Estimates as presented 22 March 2018 and that all material assumptions and technical parameters underpinning the Mineral Resource Estimate continue to apply and have not materially changed as at 30 June 2019.
